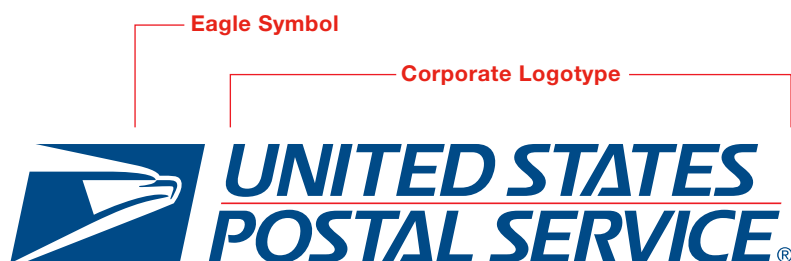


## USPS® CORPORATE SIGNATURE LOGO HORIZONTAL FORMAT — SMALL AND LARGE USE

The USPS Corporate Signature logos have been specially created to meet all reproduction specifications. Don't alter the logos in any way when reproducing them.

The Eagle Symbol and the Corporate Logotype combine to form the USPS Corporate Signature logo.



There are 2 SIZE VERSIONS of the USPS Corporate Signature logo horizontal format. Follow all size reproduction requirements.

### SMALL USE



For any use 3/8" and less, but never smaller than 7/32" of the Eagle Symbol height.

### SMALL USE:

Extra spacing around the Eagle Symbol beak



The SMALL USE has been enlarged for illustrative purposes.

Extra spacing around the letters and rule

The SMALL USE Corporate Signature logo was designed with extra spacing around the Eagle Symbol beak, letters and rule. When the SMALL USE Corporate Signature logo is reproduced between 7/32 and 3/8 inch high, the extra spacing minimizes the amount of filling in during reproduction.

### LARGE USE:

Minimum spacing around the Eagle Symbol beak



Minimum spacing around the letters and rule

The LARGE USE Corporate Signature logo was designed with minimum spacing around the Eagle Symbol beak, letters and rule. The LARGE USE is used when reproducing the logo larger than 3/8 inch high.

## USPS® CORPORATE SIGNATURE LOGO HORIZONTAL FORMAT — CLEAR SPACE REQUIREMENTS

The USPS Corporate Signature logos have been specially created to meet all reproduction specifications. Don't alter the logos in any way when reproducing them.

### CLEAR SPACE REQUIREMENTS

Always display the USPS Corporate Signature logo prominently without interference from other graphic elements such as photographs, illustrations, body text, logos or frame boundaries such as, on a webpage. Certain display requirements have been established to prevent competition from other graphic elements. **These minimum requirements identify the amount of clear space that must surround the USPS Corporate Signature logo.**

**X = The distance from the top of the angled box to the top of the Eagle's back.**



Display the USPS Corporate Signature logo prominently without interference from other graphic elements.

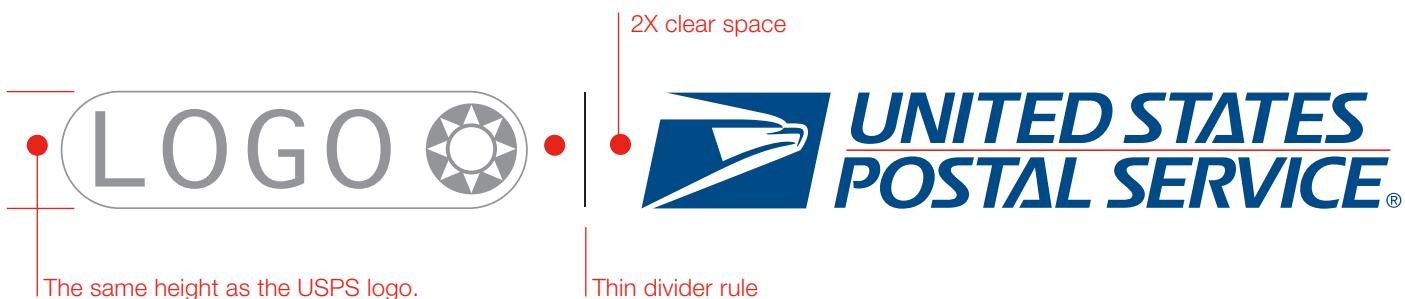

## USPS® CORPORATE SIGNATURE LOGO HORIZONTAL FORMAT — CO-BRANDING LOGO LOCKUP

The USPS Corporate Signature logos have been specially created to meet all reproduction specifications. Don't alter the logos in any way when reproducing them.

The USPS Corporate Signature logo—horizontal format is displayed the same height as co-branded logos.



When other company's logos are square or circular the logo is displayed 175% larger than the USPS Corporate Signature logo.



Maintain the 4X clear space around the USPS Corporate Signature logo within a group of logos.

## USPS® CORPORATE SIGNATURE LOGO HORIZONTAL FORMAT — EAGLE SYMBOL HEAD AND SPECIALTY PRINTING

The USPS Corporate Signature logos have been specially created to meet all reproduction specifications.

Don't alter the logos in any way when reproducing them.

When the USPS Corporate Signature logo is placed on a light background that is not white or off-white, the Eagle Symbol must appear in an outlined white box (don't invert the logo). **The Eagle Symbol head is always white.**

The USPS Corporate Signature logo **reverse use** is applied when the background is darker than a 40% tint of black. Do not distort or display the USPS Corporate Signature logo on conflicting backgrounds such as bold or busy patterns, photographs or illustrations.



The Eagle Symbol head is always white.



Do not distort the logo.



Do not print the logo on backgrounds with bold or busy patterns, photographs or illustrations.



Do not invert the Eagle Symbol.

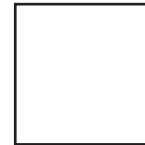

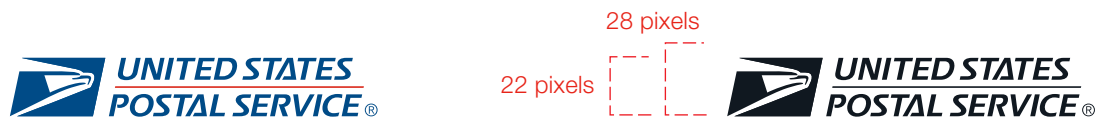
